**IN SUPPORT OF PROVIDING JEFFERSON UNION HIGH SCHOOL DISTRICT
STABLE SCHOOL FUNDING AND IMPROVING STUDENT EDUCATION
THROUGH THE SERRAMONTE DEL REY PROJECT**

WHEREAS, the Jefferson Elementary School District Governing Board is strongly committed to providing quality education to all students; and

WHEREAS, the Jefferson Elementary School District works collaboratively and closely with the Jefferson Union High School District to educate PK-12 students across multiple communities in northern San Mateo County, including Daly City, Colma, Broadmoor, and Pacifica; and

WHEREAS, the Jefferson Elementary School District and the Jefferson Union High School District both recognize the need to ensure that they are able to provide an adequate supply of teachers and other vital employees as needed to enable their schools to continue to provide quality education to their students; and

WHEREAS, the Jefferson Elementary School District Governing Board believes the overall success and stability of schools in San Mateo County and across California, and that of students and the community at large, are benefited when district employees live in the community in which they work; and

WHEREAS, the Serramonte del Rey Project is an innovative long-term plan to fund student education in the Jefferson Union High School District and stabilize its school district revenues without raising taxes; and

WHEREAS, the revenue generated from the Serramonte del Rey Project will go into the District's general fund, which can be used toward employee salaries and student programs; and

WHEREAS, a large majority of Jefferson Elementary School District students enter the Jefferson Union High School District and would benefit from the stability provided by the Serramonte del Rey Project by becoming well-rounded and well-prepared future leaders; and

WHEREAS, the Jefferson Elementary School District Governing Board supports the Jefferson Union High School District's clear vision of creating a true community space and family-friendly neighborhood, including affordable housing, attracting investments to Daly City, providing parks and open space accessible to the surrounding community, and supporting the value of homes in our district; and



NOW, THEREFORE, BE IT


- 1) **RESOLVED**, that the Serramonte del Rey Project is vital to the future of the Jefferson Union High School District; and


